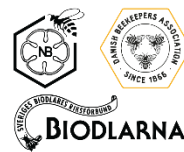

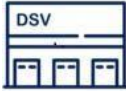

# Site Handling Tariff



## Goods via Advanced Warehouse

<b>Goods In –</b> Receiving into warehouse plus transfer from warehouse to stand	€ 25,00 per 100 kg ( € 195,00 minimum )
<b>Goods Out –</b> Transfer from stand to warehouse plus reloading ( max 3T forklift )	€ 25,00 per 100 kg ( € 195,00 minimum )

1 cbm = 333 kilos  
Warehouse handling storage covers one week before / one week after exhibition



## Site Handling

Unloading from vehicle direct to stand * (max 2,5t forklift)	€ 85,00 per. Ldm (Minimum € 230,00)
Per trailer (13,6 Ldm)	€ 975,00
Reloading direct from stand to vehicle * (max 2,5t forklift)	€ 85,00 per. Ldm (Minimum € 230,00)
Per trailer (13,6 Ldm)	€ 975,00
Forklift 2,5t & driver to assist with erection / dismantling work on stand *	€ 185,00 per hour (Minimum 30 min)
Labour	€ 105,00 per hour (Minimum 2 hours)
Larger forklifts (more than 2,5t)	Available on request
Crane charges for erection/dismantling work on stand	Available on request
Rent of pallet truck (normal)	€ 55,00 pr. day
Rent of pallet truck (long)	€ 75,00 pr. day (Minimum 1 day)



## Courier Receiving

Receipt of courier shipments and transfer to stand (up to 15 kgs)	€ 115.00 per shipment
Customs clearance of courier shipments	See customs clearance section





# Site Handling Tariff



## Storage

Collection, storage and return of Empties Goods	€ 75.00 per cbm / per piece (Minimum € 150,00)
Collection, storage and return of Full Goods material / tools etc	€ 95.00 per cbm / per piece (Minimum € 190,00)
Collection, storage and return of Express Goods <i>Will be returned max 30 minutes after access to hall is granted (Maximum 20 cbm)</i>	€ 150,00 per cbm/ per piece (Minimum € 300,00)
Accessible Storage	€ 150,00 per cbm/ per piece (Minimum € 300,00)
Partial Deliveries from warehouse (Max 4 cbm per delivery)	€ 110,00 per delivery



## Surcharges

Saturday	+50%
Sunday and BankHolidays	+100%
Insurance	€ 47,00
Work done before or after official Build-up / breakdown period	35%
Work done on 1 <sup>st</sup> and 2 <sup>nd</sup> floor	35%
Late Booking Fee – after official deadline	25%
Danish VAT where applicable	25%
Agency fee – per invoice	€ 75,00

# International Handling Tariff



## Customs Clearance (Import & Export)

Handling of ATA Carnet (safe keeping)	€ 50,00
Handling of ATA Carnet incl. customs formalities – each way	€ 225,00
Permanent Customs Clearance, Includes 1 tariff no. Additional tariff nos.	€ 185,00 € 25,00
<b>VAT, tax and duties must be pre-paid (as per outlay +15%) prior to goods release</b>	
Temporary Import Clearance, Includes 1 tariff no. Additional tariff nos.	€ 300,00 € 25,00
Bond fee – based on the shipment's CIF value	2% (minimum € 200,00)
Surcharge for clearance of goods arriving later than 3 workdays before requested stand delivery	100%
Export Documents, includes 1 tariff no. / T1 fee - per document	€ 165,00
Additional tariff nos.	€ 25,00
Customs inspection (mandatory for re-export of temporary goods)	€ 225,00

! Important notice - for shipments under DSV bond, DSV must arrange the return transport.

\*DSV may under certain conditions demand full deposit of VAT+duties on temporarily imported shipments

\* Please note, ATA carnet's and non-ATA Carnet items cannot be cleared on the same Customs Entry / clearance.

\* Any additional costs incurred to courier documents such as ATA Carnets will be charged accordingly.



## Airfreight Shipment Handling From/To Airport (CPH)

From/To free arrival CPH to DSV Advanced warehouse – up to 500 kg	€ 2,50 per kg. (minimum € 250,00)
For shipments exceeding 501 kg.	Please ask for rate
Fuel Surcharges	7 %

1m3 = 167kg // Airline storage / additional charges will be charged as per outlay plus 10%
